- 1. Laying hens have unlimited access to outside, 24 hrs, 365 days a year. Provide a minimum of 4m of pop-holes per 100m2 area of the house.
- 2. No de-beaking or de-toeing. It is FRENZS preference to rear pullets without beak tipping however if these are not available infra-red laser tipping may be carried out on chicks at 1 to 3 days old by industry approved operators.
- 3. Up to 500 birds per acre or 1200/hectare is allowed
 Up to 2000 birds per shed (seven birds per square metre of available roofed area)
- 4. Pasture management by rotational grazing. Open air runs shall be mainly covered with fresh pasture.
- 5. Shelter in each paddock, via hedges, trees or natural means to provide shelter, shade and protection for birds and to encourage outside foraging. No Chemical sprays, antibiotics or hormones are to be used.
- 6. Provide 170 mm perching per bird, 4 cm per bird feed space, 2.5cm per hen for troughs or 1cm per hen for circular drinkers or one 1 nipple per 10 hens. 1 bell drinker per 100 hens, plus outside troughs in races & paddocks. 7 birds per nest box or (1 square meter per 120 birds)
- 7. Lighting will meet the minimum standard No 7 in the Layer Hens Code of Welfare 2012.
- 8. Day old chickens must be reared on the floor on untreated shavings or suitable dry litter.
- 9. Pullets benefit if reared with access to outdoors by 8 weeks of age. Choose pullet rearers that offer this option.
- 10. Only farm Free-Range birds. NO CAGED (OR)BATTERIES, NO BARNS, NO COMPROMISES For the operations associated with:
